### ELECTION INTEGRITY

### **OPPOSE HB1368 – State control of local mental health board | Pending in the Senate Health and Human Services Committee |**

- Violates the principle of local self-governance — decisions should be made closest to the people they affect.
- Concentrates power in one unelected bureaucrat with no meaningful checks or balances.
- State-mandated "unified bylaws" eliminate local flexibility and impose one-size-fits-all governance.
- This is the same centralization playbook seen in California — Georgia must not follow that path.
